Radiator Heat Shield

• Remove the clutch hose from the clamp on the left frame tube to gain access to the upper left radiator screen mount screw.



NOTE: o Cover the frame with tape on the left and right sides (right side shown, left side similar) to prevent scratches during shield installation



- Remove and discard upper left and upper right radiator screen mount screws (right side shown, left side similar).
- Install the heat shield along the upper edge of the radiator and attach the shield and the screen with the radiator screen mount screws provided in the kit.



- Remove the tape from the frame rails.
- Install the clutch hose in the clamp on the left frame tube.

Front Cylinder Exhaust Cover

NOTE:

- o Apply penetrating oil to the exhaust cover clamp screws prior to loosening.
- Loosen the exhaust pipe cover clamp screws.
- Remove and discard the exhaust cover.



• Install exhaust pipe cover provided in the kit.

Rear Cylinder Exhaust Cover Insulation

NOTE:

- o Apply penetrating oil to the exhaust cover clamp screws prior to loosening.
- Remove the rear cylinder exhaust pipe cover.



NOTE:

o Remove any oil or dirt from back of exhaust pipe cover.

• Install the provided Insulation to the exhaust pipe cover as shown below picture.



NOTE:

o Insulation should be installed so it does not interfere with the clamp stay.



• Reinstall the exhaust pipe cover with installed insulation.
